Fair Housing History: As early as 1963, citizen groups in Oak Park began lobbying for open housing legislation. At the same time, the Oak Park-River Forest Citizens Committee for Human Rights sponsored events to attract black residents. 1963 also saw the creation of the Village of Oak Park's Community Relations Commission. In 1966, the Village of Oak Park amended its Village Code, making it unlawful for any person or corporation to sell, rent, or purchase any property by making representations that the property will go down in value by reason of the race, color, or religion of persons who have or may move into the vicinity of the property involved. In 1968, Oak Park established a Community Relations Department, and passed its landmark Fair Housing Ordinance (ahead of the federal government). Groups in support of the Fair Housing Ordinance included the Oak Park-River Forest Citizens Committee for Human Rights, the Oak Park-River Forest League of Women Voters, and Oak Park and River Forest Religious Organizations like the Baha'i. However, not everyone in Oak Park was in favor of passing a Fair Housing Ordinance. In particular, the Oak Park Board of Realtors was concerned that the terms of such an ordinance would be so general that compliance would be impossible, thereby harming the business of realtors. The Oak Park Board of Realtors also conducted a leafleting campaign in opposition to the fair housing movement, and ran an ad in the 1964 *Village Economist* which stated, "Let the voice of the people decide the issue of forced housing by referendum."

Additionally, the Oak Park Referendum Group petitioned the Village of Oak Park to hold a referendum on the issue of fair housing, which the Group decried as 'Forced Housing.' The Referendum Group contended that all races already lived in Oak Park under the present federal laws, and as such a Village fair housing law was unnecessary. Moreover, the Oak Park Referendum Group maintained that the Oak Park Board of Trustees would unconstitutionally take away Oak Parkers' property rights by enacting a fair housing law. The Referendum Group obtained 10,156 signatures on their petition, but ultimately the case was dismissed in the circuit court of Cook County and no referendum was held. Other Oak Parkers' reactions to the prospect of a Fair Housing Ordinance ranged from racist, to fearful, to uncertain.

In 1971, the Village of Oak Park created the Community Relations Department. The Oak Park Housing Center, known today as the Oak Park Regional Housing Center, was established in 1972 to help prospective home owners move into Oak Park and to maintain and achieve racial diversity in the village. Throughout the 1980s and 1990s, Oak Park continued its work on integration and diversity, creating the Diversity Task Force in 1984. Today, Oak Park celebrates its history as an early adoptee of a Fair Housing Ordinance, and is known as a diverse community.

- Scope and Content Note: The materials in the Oak Park Fair Housing Collection cover the fair housing movement in Oak Park from its inception to its passage as a village ordinance. Additionally, the collection contains materials created after the passage of the fair housing ordinance and to the present day. Materials related to the Oak Park Community Relations Commission, Oak Park Public Schools, Oak Park-River Forest Citizens Committee for Human Rights, Oak Park Housing Center, Oak Park-River Forest League of Women Voters, Oak Park Board of Realtors, Oak Park Referendum Group, and Oak Park and River Forest Religious Organizations are also included. The contents of the Oak Park Fair Housing Collection include organizational documents, ordinances, reports, meeting minutes, correspondence, newspaper articles, scholarly articles, and books.
- Immediate Sources of Acquisition: The materials in the Oak Park Fair Housing Collection came in two separate donations from the Oak Park Chamber of Commerce in 1993 and longtime Oak Park resident Helen M. Stevens in 1994. The donations are under the respective accession numbers 1993.30 and 1994.26. Oak Park Fair Housing materials from each

donation have been combined here for ease of access and use by researchers. For more details on each respective donation, these accession numbers are individually accessible in the Past Perfect archival management system in OPRF Museum's research center. Related Oak Park Fair Housing materials from other donations may be added to this collection in the future at the discretion of the Director.
